All riders must have upper body control and be able to sit up straight with their head against the seat back.
Riders with an amputation and/or prosthesis are encouraged to visit the Ride Accessibility Center prior to visiting the attraction.

◆ High Thrill Attraction - High speeds with extremely unusual and stressful physical forces. This ride contains startling and unexpected thrills appropriate for only the most healthy and physically able riders.

■ Moderate Thrill Attraction - Moderate speeds with unexpected movements and unusual and stressful physical forces. This ride may contain unanticipated thrills.

● Mild Thrill Attraction - Low speeds with expected movements and anticipated thrills.

1* **Amputation Above the Knee** - A rider with one or two amputated legs above the knee with or without prosthesis shall not be allowed on the ride.

2* **Amputation Above the Knee** - A rider with one amputated leg above the knee with or without prosthesis may ride provided such rider has the ability to hold on with two functioning (natural or prosthetic) hands. Prosthesis must be secured.

3* **Amputation Below the Knee** - A rider with one or two amputated legs below the knee may ride provided such rider has the ability to hold on with two functioning (natural or prosthetic) hands. Prosthesis must be secured. **Prosthesis must be removed on Barnstormer, Drop Line, & Wild Eagle.**

4* **Amputation of Arm or Hand** - A rider with one amputated arm or hand, with or without prosthesis, may ride provided such rider has the ability to hold on with one functioning hand (natural or prosthetic) and to brace self with two functioning (natural or prosthetic) legs. Prosthesis must be secured.

5* **Functioning Leg** - *Daredevil Falls riders must have at least one functioning leg (may be a prosthetic leg) to participate in this attraction.
*Thunderhead riders must have one functioning natural (not a prosthetic) leg while the other leg must not be amputated above the knee.
*Lightning Rod riders must have two natural (not a prosthetic) legs, including feet to participate in this attraction.

6* **Amputation of Arm or Hand** - *Lightning Rod riders must have the ability to brace with at least one functioning (natural or prosthetic) hand.
*Drop Line riders must have the ability to hold on with one functioning natural hand (not a prosthetic) with the second arm extending below the elbow. Prosthesis must be removed.



A rider with certain amputations that would normally be excluded from Wild Eagle may be permitted to ride with the use of a full body harness if the rider meets certain physical requirements. Please visit the Ride Accessibility Center for more information.
